What type of information we have

We may collect and process the following personal data about you:

- Identifying information such as your name, address, email address, telephone number and other contact information:

How we get the information and why we have it

 - o Any personal information provided by way of correspondence with us by phone, e-mail or otherwise.
- Personal information we receive indirectly from third party sources, such as:
 - o Information that is publicly available over the internet.

Under the Data Protection (Jersey) Law 2018, the lawful bases we rely on for processing this information are:

- B. We have a contractual obligation.
- C. We have a legal obligation.
- D. We have a legitimate interest.

What we do with the information we have

We may use the information that you have given us in order to:

- Conduct administrative or operational processes within our business;

Your right to restriction of	You have the right to ask us to restrict the processing of your information in
processing	certain circumstances.
Your right to object to processing	You have the right to object to the processing of your personal data in certain
	circumstances.
Your right to data portability	You have the right to ask that we transfer the information you gave us to
	another organisation, or to you, in certain circumstances.
